

Formatting Guidelines for Extended Abstracts

Length, Format, and Font

Extended abstracts not exceeding 1000 words and their short summaries (up to 200 words) must be prepared using the **provided template**. Tables, charts and references, except for the cover page, contribute to the word count. Abstracts should be in Calibri font, 12pt, single-spaced with a blank line between paragraphs. Use single quotation marks and British English spelling throughout. All figures and tables should be placed in the text on the page they are first referenced or on the following page.

Versions for Extended Abstracts

Please submit **two versions** of your extended abstract:

Version 1

Version 1 should include a **cover page** with the names, affiliations and contact details of all authors, three to six keywords and JEL code, if available. On the next page following the cover page, the title of the extended abstract should be repeated. Extended abstracts have to include the following sections:

Page 1: **Cover page**
Page 2: **Title of the extended abstract and summary**
Page 3 and following: **1 Research questions**
2 Data and methods
3 Main results
4 References

THIS STRUCTURE IS OBLIGATORY! All headings should be in the same type size and font as the text as exemplified above. Please use the provided Word-Template.

File name: **first author_website.doc** (e.g., mueller_website.doc).

Version 2 (for double-blind review)

The first page of Version 2 should only show title and summary of the extended abstract. Extended abstracts have to include the following sections:

Page 1: **Title of the extended abstract and summary**
Page 2 and following: **1 Research questions**
2 Data and methods
3 Main results
4 References

THIS STRUCTURE IS OBLIGATORY! All headings should be in the same type size and font as the text as exemplified above. Please use the provided Word-Template – **do not forget to remove the cover page and make sure that the file does not carry any personal information.**

File name: **first author_review.doc** (e.g., mueller_review.doc).

Footnotes

No footnotes are allowed.

Tables and Figures

- Not more than two tables and figures are allowed in the paper proposals.
- Each table and figure must be followed by a source statement, and must explicitly be referred to in the text.

References

References are cited in the text by giving the name of the author and year of publication plus - in the case of quotations or an exact reference - the page number; all in parentheses: (SWINNEN 1997: 12) or (ZELLER et al. 1997).

- All publications cited in the text must be presented in an alphabetical list of references following the text of the extended abstract.
- The extended abstract should be carefully checked to ensure that the spelling of author's names and dates are exactly the same in the text as in the reference list.
- Internet Sources: Please give the full link and date of the download
- Use the abbreviation “et al.” (only) in the text if there are more than two authors.
